Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 1.12 tCO₂e by 2038. This is a reduction of 20%.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 0.05 tCO₂e, a 3.5%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract.

- Cycle to work scheme
- Switch to low energy lighting and heating

In the future we hope to implement further measures such as:

- Reduction in private passenger vehicle use.
- Further working from home initiatives.
